- **[Safeguarding Sciences Workshop](#)**
  - NSERC Alliance is just the first federal program that has added requirements around the National Security Guidelines. Since risk management often falls on administrators, this session is a good fit for the Network.
  - Springboard will host a workshop in September that will be open to our IEPs and faculty/researchers.
  - The workshop will be 2 hours in length (including 30-minutes of Q&A)
  - Hart shared a Paper on the topic (**see attached**) titled 'Picking flowers, making honey: The Chinese military's collaboration with foreign universities'
  - There was a particularly good discussion on this topic, so be sure to watch the recording linked above if you'd like check that out.
